1. Collaborative Organizations / Opportunities:

- a. PPRWA Shaffer reported that CSU was leading a study of indirect potable reuse. The District would benefit from participating in the study because of the major shareholder rights it has with Chilcott Ditch.
- b. Loop Water Authority The Loop is preparing a RFP for consulting and engineering firms to design water treatment facilities to bring Fountain Creek water to drinking standards.

2. Operations Update

- a. Water Report LaFontaine reported there were two shears and no service failures in December. He also discussed how the District is working with the EPA for monitoring PFAS chemicals and lithium. Sanitary Water System Survey will be completed in 2025
- b. Sewer Report: Nothing to report

3. Engineers Report

a. District Construction/Planning Projects:

- a. Valley Vista Sewer Re-Route Working on an agreement with Classic Homes.
- b. Main Lift Station Rehabilitation Had a bid opening where two bids were submitted that came in much higher than expected. JVA will review and the project may be redesigned.
- c. Highway 105B No update since JVA sent plan to El Paso County.

- **d.** CWTP Dawson Well The new well is yielding over 40 gallons per minute.
- e. Well 22 Transmission Pipeline Substantial completion did not pass and plan to rewalk at the end of the week. Final grading and erosion control will be held off until Spring.
- e. North Saddle Tap Replacements R&R project to hopefully begin in May to replace 121 saddles in the Northwest corner of the District.
- f. Annual Sliplining Contract Sewer R&R project has identified 2000 linear feet of pipeline to be sliplined. Project is out to bid.

4. WWSD Subdivision/Development Status Update

- a. Monument Junction Classic is having another big push this year on the South and West side of the current development.
- **b.** Waterside No action with the final plans, no sales agreement or supplemental water agreement as of today.
